

## Wayne County – Polling Place Buffer Zones March 3, 2025 Primary Election

The following is a list of Wayne County polling places and a description of each buffer zone. Buffer zones are designated in accordance with G.S. 163-166.4(a). The County Board of Elections shall, where practical, set the limit at 50 feet from the door of entrance to the voting place, measured when that door is closed, but in no event shall it set the limit at more than 50 feet or less than 25 feet.

The precinct officials will mark the buffer zones at each location with signs designating no electioneering beyond this point.


- 01:** Fremont Town Hall, 126 East Main Street, Fremont, NC 27830  
Electioneering is allowed 25 feet from the front door of the building.
- 02:** Eureka Methodist Church, 128 North Church Street, Eureka, NC 27830  
Electioneering is allowed 50 feet from the fellowship hall door.
- 03:** Little River Fire Station, 622 Gurley Dairy Road, Pikeville, NC 27863  
Electioneering is allowed 50 feet from the side door of the station.
- 04:** Pikeville Fire Station, 110 Hooks Grove Church Road, Pikeville, NC 27863  
Electioneering is allowed 50 feet from the side door of the station.
- 05:** Belfast Fire Department, 3212 North US 117 Highway, Goldsboro, NC 27530  
Electioneering is allowed 50 feet from the side door of the station.


