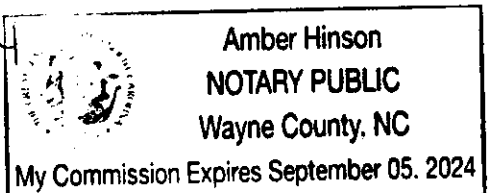

As I was reviewing your candidate filing paperwork today it was noticed that your legal last name in our voter registration system is spelled Oliver, but you wanted to place the last name Olliver on the ballot. This is not allowable. You must use your legal last name, therefore your name on the ballot will be placed as *Andrade Oliver Sr.*

If our voter registration records are incorrect, please visit our office to update your voter registration. In your past voter registration, candidacy and campaign finance paperwork I see that you have used Oliver and Olliver interchangeably but this is not allowable.
