The audit of the Committee to Elect J. Jerome Newton Mayor's semi-annual report is complete and the following discrepancies were noted.

- The previous report stated the committee ended with \$1198.20 in cash on hand, however block 11D on the CRO-1000 and line 4 "Total this Reporting Period" list \$1,220.57 as the beginning cash on hand for this reporting period.
- Line 4 "Total this Election Cycle" of the CRO-1100 should be \$0 as the committee indicated in its initial report that it began with \$0 cash on hand.
- Line 5 of the CRO-1100 indicates \$125.00 in contributions this reporting period but there is no accompanying CRO-1205.
- "Total this Election Cycle" Lines 5, 6, 12, 13a, 17, and 18 of the CRO-1100 are wrong based on the addition of contributions listed in this report and the "Total this Election Cycle" column from the previous report. Line 19 is left blank.
- Line 17 "Total this Election Cycle" indicates an additional In-Kind contribution since the last report, however no In-Kind contribution is listed on line 19 for this reporting period, nor is one included on the CRO-1210 and there is no accompanying CRO-1510.

The audit of the Committee to Elect J. Jerome Newton Mayor's amended Semi-Annual Report is complete and the following discrepancies were found.

- Line 19 of both columns on the CRO-1100 should be the same as the committee began with \$0 cash on hand. Below are the corrections needed.
- The cash on hand to start this reporting period should be \$1,098.20. (Upon review of the previous report, the committee added \$100 to the COH total under the "Total this Election Cycle" column instead of under the "Total this Reporting Period" column in the Pre-election Report). Block 11d on the CRO-1000 and Line 4 under the "Total This Reporting Period" of the CRO-1100 should both indicate \$1,098.20 as the beginning cash on hand for this period. This change will also require a correction of Line 19 under the "Total this Reporting Period" column as the total is \$100 more than it should be. Line 4 of the "Total this Election Cycle" column is correct at \$0.
- Line 6 of the "Total this Election Cycle" column on the CRO-1100 is incorrect. The previous report indicated \$3,967.50 in this line item and the current report shows an addition of \$1,500 in contributions for this period. The "Total this Election Cycle" on this report is \$67.50 short. This change will also require a correction to Lines 12 and 19 of this column on the CRO-1100 as both are \$67.50 less than they should be.
- After these corrections, Line 19 of both columns on the CRO-1100 should be the same.
