**The meeting was called to order at 5:00 p.m. by Mr. Edwards.**

**I. Approval of November 7, 2022 Meeting Agenda**

- Mr. Wright made a motion to approve the November 7, 2022 meeting agenda. Mr. Artis seconded the motion and the vote was unanimous.

**II. Director's Update**

- Ms. Risku provided the Board with the following updates:
  - A total of 21,416 voters voted early and 939 voted by mail so far. Staff expects around 14,000 Election Day voters.
  - There is a planned protest outside the State Board tomorrow and they've advised counties to be prepared for similar events. Also, there are groups encouraging people to vote as late in the day on Election Day in order to disrupt the process.
  - There was a shooting in front of the office earlier today but it was unrelated to elections. Law enforcement presence has been around the building and will be doing check-ins on polling places tomorrow.
  - Ms. Cowan stated that it seems to be the same people causing problems and that the Board should split up and visit polling places throughout the day. Ms. Risku responded that should time permit, she and Mr. Sullivan will be doing the same.

**III. Absentee by Mail Ballot Applications**

- Approval
  - Ms. Risku presented the Board with (331) civilian, (13) military and (9) Overseas absentee ballots for approval.
  - Ms. Risku presented the Board with (7) improperly executed absentee ballots.
  - Ms. Cowan made a motion to approve (353) properly executed absentee ballots and disapprove (7) improperly

### IV. Signing of the *Certified Executed Absentee List*.


