### Wayne County Board of Elections Board Meeting November 18, 2022

**The meeting was called to order at 11:00 a.m. by Mr. Edwards.**

**I. Approval of November 18, 2022 Meeting Agenda**

- Ms. Cowan made a motion to approve the November 18, 2022 meeting agenda. Mr. Artis seconded the motion and the vote was unanimous.

**II. Absentee ballot challenge hearings: Carey Eugene Bostic and J.B. Price**

- Ms. Risku informed the Board that both voters are being challenged as they are deceased. Both voted by mail earlier in the election cycle but the Board received notice via the Register of Deeds office that they passed away prior to Election Day. Both were sent notice of the challenge and hearing via certified mail.
- Mr. Edwards opened the floor for anyone wishing to speak to either challenge. No one presented to speak. Ms. Cowan made a motion to sustain both challenges. Mr. Wright seconded the motion and the vote was unanimous.

**III. Signing of *Final Pollbook of Absentee Voters***

- The Board signed the *Final Pollbook of Absentee Voters*.

**IV. Canvass of November 8, 2022 Election**

- Ms. Risku presented the Board with the final canvass documents for their review and signature.
- Ms. Risku informed the Board that 35,459 ballots were cast in the election and 35,459 voters had voter history. 12,884 voters voted on Election Day, 21,416 voted during Early Voting, 1,073 voted Absentee by Mail and 86 voted Provisional ballots.
- Mr. Hull made a motion to canvass the November 8, 2022 election. Ms. Cowan seconded the motion and the vote was unanimous.

### V. Public Comment


