The audit of the Elect Wade Leatham committee's 4th Quarter Report is complete and the following discrepancies were noted:

- The CRO-1100 indicates repayment of \$2,590.33 of the original \$5,000.00 loan. The committee must account for the remainder of the loan as it is considered outstanding still. If the remainder of the loan was forgiven, a CRO-1440 is required and the amount should be indicated on line 26 of the CRO-1100. If the remainder has not been forgiven, a CRO-1430 should be filed and the committee must remain open until the balance is paid or forgiven.
- If the committee intends to close, a Certification to Close must be filed. However, it cannot be filed as long as the committee has an outstanding balance. If the committee intends to go inactive, a Certification of Inactive Status is required. If the committee intends to stay active, no action is required until the next quarterly report is due.

- A cover sheet was not submitted with this report. The cover sheet is a requirement for all report submissions.
- Line 15 and line 26 of the CRO-1100 should not be the same. The first 4th Quarter Report submission indicated a repayment of \$2,590.33 of an original \$5,000.00 loan. This report also lists that as the forgiven amount. The total of the two should not be more than the original loan amount.
- As indicated in the original audit, the committee must account for the remainder of the loan. If it was forgiven, that number should be listed on line 26 of the CRO-1100 and should be accompanied by a CRO-1440 and a CRO-6200. Again, this is not the amount that was repaid, but what was forgiven.
- Blocks e, f, and h of the CRO-1440 are incorrect.
- No CRO-6200 was provided. This must accompany any CRO-1440.
