Good morning Mr. Wallace,

If you would like to officially withdraw from the Pikeville Commissioner contest, you must complete the attached form and submit the original to our office. Until this form is completed and verified by our office, you will still be a candidate. This must be done immediately as we are in the process of coding ballots for the election. Please make this a priority.

Your committee is still out of compliance by not returning your committee organization paperwork within 10 days of filing for office. The day you filed for office obligated you to 08 NCAC 21.0202 and NCBS 163-278.10. Candidacy and committee compliance are two separate entities. Please submit the Statement of Organization paperwork immediately, along with the attached Withdrawal form. We may then withdraw you from the contest and you may close your committee once the election cycle is over. Again, candidacy and campaign finance compliance are two separate entities.

If you have questions or need assistance, please schedule an appointment with our office to complete this process. We will be happy to assist you with the paperwork.

Per North Carolina campaign finance law, all candidates are required to complete a Statement of Organization within 10 business days of filing for office. Your report is now 2 weeks past due.

Failure to bring your campaign committee into compliance by submitting a Statement of Organization will result in you being reported to the North Carolina State Board of Elections for penalty assessment.
