The meeting was held at the properly noticed date and time and a quorum was present. Mr. Edwards called the meeting to order at 11:00 a.m.

I. Approval of the November 17, 2023 Agenda

1. Ms. Cowan made a motion to amend the agenda to add Manual Edit as the second item on the agenda. Mr. Hull seconded the motion, and the vote was unanimous.
2. Ms. Cowan made a motion to approve the November 17, 2023 meeting agenda as amended. Mr. Wright seconded the motion, and the vote was unanimous.

II. Manual Edit

1. Ms. Risku presented the Board with (1) supplemental absentee ballot that was cast timely via the Visually Impaired Person Portal that needed to be added via manual edit. Mr. Wright made a motion to approve the manual edit. Mr. Artis seconded the motion, and the vote was unanimous.


