The campaign finance guide, available on the North Carolina State Board of Elections' website, and the NCSBE Campaign Finance Mandatory Compliance Training explain that in-kind contributions are, in fact, contributions and must be listed on your committee's disclosure reports as such. As I have previously explained, in-kind contributions must be listed on the receipts as well as the expenditures side of the report.

Self-funding, in-kind or otherwise, does not absolve you of your responsibilities to the public or your adherence of North Carolina statutes and regulations regarding campaign finance reporting.

The audit of the Clark campaign's amended Organizational Report is complete and the following discrepancies were noted.

- Block 2 of the CRO-1100 should be the Report name, not the form name.
- Lines 6 and 12 of the CRO-1100 cannot be \$0 as the committee has accepted in-kind contributions.
- Line 18 of the CRO-1100 should not be \$0 as the committee has accepted in-kind contributions.
- Line 19 should not be left blank. If the committee has \$0 cash on hand, that should be noted in this line.
- The CRO-1210 is still missing. All in-kind contributions must be listed on a CRO-1210 as well as a CRO-1510 as they are accounted for as contributions and expenditures.
