

# EUREKA

## CHAPTER 90.

### AN ACT TO INCORPORATE THE TOWN OF SAUL'S CROSS ROADS, IN THE COUNTY OF WAYNE.

The General Assembly of North Carolina do enact :

SECTION 1. That the village of Saul's Cross Roads, in incorporated in the county of Wayne, be and the same is hereby incorporated by the name and style of the town of Saul's Cross Roads, and be subject to all the provisions contained in chapter one hundred and eleven of Battle's Revision and Powers, the act amending said chapter.

Sec. 2. That the corporate limits of said town shall be ~~corporate limits~~ as follows: Beginning at a stake in the centre of crossing of the Freemont and Stantonburg road and the Bull Head and Black Creek road, and thence south forty-eight and one-half [degrees] east one hundred poles to a stake in L. D. Minshaw's field, thence south four and one-half [degrees] west eighty poles to a stake, thence north forty-eight and one-half [degrees] west one hundred and sixty poles to a stake in James Witherington's field,

thence north forty-one and one-half [degrees] east one hundred and sixty poles to a stake, thence south forty-eight and one-half [degrees] east one hundred and sixty poles to a stake, thence south forty-one and one-half [degrees] west eighty poles to the beginning.

Sec. 3. That the officers of said incorporation shall consist of a mayor, three commissioners and a town constable, who shall be appointed by the mayor and commissioners, and Henry J. Sauls shall fill the office of mayor and J. N. Borden, Spright Sauls and James Witherington shall fill the office of commissioners.

Sec. 4. That said officers shall continue in office until the time prescribed by law for the election of officers of incorporated towns, and then the annual elections of officers of said town shall be as prescribed by law.

Sec. 5. That this act shall be in force from and after its ratification.

AN ACT TO CHANGE THE NAME OF THE TOWN OF  
SAUL'S CROSS ROADS TO EUREKA.

The General Assembly of North Carolina do enact:

Section 1. That the charter of the town of Saul's Cross Roads, in the County of Wayne, be and the same is hereby amended so as to make the name of said town Eureka.

Sec. 2. That this act shall be in force from and after its ratification.

In the General Assembly read three times, and ratified this the 1st day of March, A. D. 1901.

CHAPTER 185.

AN ACT TO CHANGE THE NAME OF THE TOWN OF SAUL'S CROSS ROADS TO EUREKA.

The General Assembly of North Carolina do enact:

Section 1. That the charter of the town of Saul's Cross Roads, in the County of Wayne, be and the same is hereby amended so as to make the name of said town Eureka.

Sec. 2. That this act shall be in force from and after its ratification.

In the General Assembly read three times, and ratified this the 1st day of March, A. D. 1901.

AN ACT TO INCORPORATE THE TOWN OF SAULS'  
CROSS ROADS, IN THE COUNTY OF WAYNE.

The General Assembly of North Carolina do enact.

Sec.1st. That the village of Sauls' Cross Roads, in the County of Wayne be, and the same is hereby incorporated by the name and style of the town of Sauls' Cross Roads, and be subject to all the provisions contained in Chapter One Hundred and Eleven of Battles' Revisal and the act amending said chapter.

Sec.2nd. That the corporate limits of said town shall be as follows, beginning at a stake in the center of crossing of the Freemont and Stantonburg road and the Bull Head and Black Creek road, and thence South  $48\frac{1}{2}$  East 100 poles to a stake in L.D. Minchen's field, thence South  $4\frac{1}{2}$  West 80 poles to a stake, thence North  $48\frac{1}{2}$  West 160 poles to a stake in James Wethington's field, thence North  $41\frac{1}{2}$  East 160 poles to a stake, thence South  $48\frac{1}{2}$  East 160 to a stake, thence South  $41\frac{1}{2}$  West 80 poles to the beginning.

Sec.3rd. That the officers of said incorporation shall consist of a Mayor, three commissioners, and a town constable, who shall be appointed by the Mayor and Commissioners, and Henry J. Sauls shall fill the office of Mayor and J.N. Bardin, Spright Sauls and James Witherington shall fill the offices of Commissioners.

Sec.4th. That said officers shall continue in office until the time prescribed by law for the election of officers of incorporate towns, and then the annual election of officers of said town shall be as prescribed by law.

## H. B. 641 CHAPTER 459

## AN ACT TO PROVIDE PROCEDURE FOR THE ELECTION OF OFFICIALS FOR THE TOWN OF EUREKA IN WAYNE COUNTY.

*The General Assembly of North Carolina do enact:*Town of Eureka,  
biennial election  
of town officials.

SECTION 1. The Governing Body of the Town of Eureka in Wayne County shall call an election to be held on the first Tuesday after the first Monday in May, 1950, and biennially thereafter, for the purpose of electing officials for the Town of Eureka, formerly known as the Village of Sauls' Cross Roads in Wayne County.

Conduct of elec-  
tion.

SEC. 2. The elections provided for herein shall be called and conducted, and the results determined and certified, in accordance with the provisions of Article 8 of Chapter 160 of the General Statutes of North Carolina, and such other laws governing and controlling general municipal elections at the time such election may be held.

Terms, etc., of in-  
cumbent officials  
extended.

SEC. 3. The terms, responsibilities and authority of all officials holding the several municipal offices in the Town of Eureka at the time of the ratification of this Act are hereby extended and continued until the first Tuesday after the first Monday in May, 1950, or until their several successors are named and qualified.

SEC. 4. Section 8 of Chapter 90 of the Laws of North Carolina, Session 1879, and all other laws and clauses of laws in conflict with this Act are hereby repealed.

SEC. 5. This Act shall be in full force and effect from and after its ratification.

## CHAPTER 136

## AN ACT TO AMEND CHAPTER 459 OF THE SESSION LAWS OF 1949 SO AS TO INCREASE THE MEMBERSHIP OF THE BOARD OF COMMISSIONERS OF THE TOWN OF EUREKA IN WAYNE COUNTY.

*The General Assembly of North Carolina do enact:*

Section 1. Section 1 of Chapter 459 of the Session Laws of 1949 is written to read as follows:

"Section 1. The governing body of the Town of Eureka in Wayne County shall consist of five (6) commissioners. At the election to be held in said town on the first Tuesday after the first Monday in May, 1950, and biennially thereafter, there shall be elected in said town five (6) commissioners who shall serve for terms of two years each and until their successors are elected and qualified."

Sec. 2. All laws and clauses of laws in conflict with this Act are hereby repealed.

Sec. 3. This Act shall be in full force and effect from and after its ratification.

In the General Assembly read three times and ratified, this the 26th day of March, 1959.

Sec. 5th. That this act shall be in force from  
and after its ratification.
